A friendly reminder to all FSM citizens that the FSM Government, through the Department of Justice, Division of Immigration and Labor, has recently implemented the use of a new version of passport application. This new application contains additional question(s) that are required to be completed.

To verify you are using the new application, the new application should have a “FSM FORM 500IB-REVISED FORM 5001A” designation in the upper right corner and contain a question on whether the applicant has been convicted of a crime. (These are circled in red in the sample image above at right.) Please note also that the form is two pages and that there are important instructions on the second page.

The latest application can be downloaded at the link in the box to the right. We continue to encourage all citizens to utilize this updated application rather than any older versions.
